I believe my counseling experience at Espanola Valley High School, "EVHS", as well as my prior experience in education, in behavioral support and in mental health, make me an excellent candidate for your program. As Head Counselor at a high-needs school, I provide a comprehensive School Counseling program that identifies and addresses the needs of all students, one that helps them explore, identify and pursue career goals while also supporting their social emotional development and academic success.

In my four years at EVHS, a high school where the majority of students are Hispanic, low income and first generation, I have moved with the class of 2020 from their first day of high school to graduation. I helped them acclimate to high school, adjust to a new set of freedoms and responsibilities, as well as navigate the college and financial aid application systems. I regularly went into the classroom to help students with career exploration and planning, as well as meeting with students one-on-one. Additionally, I organized staff teams to support struggling students.

During my second year, I was asked to take the lead as the Department Head. I began implementing American School Counselor Association standards and guidelines to better serve our students, as well as collaborating to develop an Attendance Review Board to address chronic absenteeism. I also serve as a member of the EVHS Redesign team, a nationwide partnership with Johns Hopkins University to reevaluate and reimagine the traditional high school model.

When I started, EVHS was transitioning to a new School Information System, Synergy. I quickly became comfortable with the program and someone that other staff members came to for help. I have continued to lead in utilizing more of its features, such as improving and streamlining scheduling, and creating Early Warning Systems. Additionally, for several years I took the lead in preparing for, and administering state tests for all students at the school. I have also twice developed, administered, and interpreted student surveys on course interest and campus climate.

Though we will miss New Mexico, as native Vermonters, my wife and I are returning home to the northeast to be closer to family.
